The Awards

Two, \$1,500 scholarships to be awarded to two (2) students and their accredited educational institution. (\$1,500 awarded to each winner)

Eligibility

The applicant must be a member of Bucks First Federal Credit Union (BFFCU) in good standing, and must be enrolled as a high school senior at the time of application. Scholarship funds must be used at an accredited educational institution by January 31, 2012, for tuition or textbooks only. Employees of BFFCU, Directors, Volunteers, and their immediate families are not eligible to participate.

3. _____ Certification and Release Authorization

This section must be signed by applicant and parent/guardian and dated.

4. _____ High School Transcript

Official high school transcripts containing straight, not weighted, cumulative numeric grade points as of the end of the 2nd marking period of the 12th grade. If this system is not used by your school, please ask your guidance counselor to provide this format on your transcript.

5. _____ SAT/ACT Transcript

SAT/ACT Transcripts must be provided through your guidance office.

6. _____ Separate Letter of Recommendation

Recommendation must be provided from a school official (i.e. teacher, guidance, advisor, principal, etc.)
